A proposed 19<sup>th</sup> Avenue Trail and pedestrian crossing at 19<sup>th</sup> Avenue and Highway 18 were discussed. City engineers will evaluate the location and develop plans for the project.

The bid tab for East Meadow Road Extension was reviewed.

Council member Faber introduced Resolution No. 775-21 entitled, "Resolution to Hire an Individual for the Marketing – Event Center Coordinator Position" and made a motion to adopt.
