REGULAR COUNCIL MEETING Thursday, December 22, 2022 12:00 PM

PRESENT: Mayor Van Otterloo, Council members De Kam, Koldenhoven, Faber and Van't Hul. City Administrator Van Maanen. ABSENT: City Clerk Vande Kamp.

ALSO PRESENT: City Attorney Winterfeld; Police Chief Warburton; Economic Development Director Miller; and City Foreman Van Ginkel.

The Mayor called the meeting to order.

The Pledge of Allegiance was recited.

On a motion by Granstra and a second by DeKam to approve the agenda with the addition of a discussion to purchase of maintenance equipment. All ayes, motion carried.

The Council reviewed an update on the 2022 Water System Improvement Project.

On a motion by Koldenhoven and a second by Van't Hul to approve change order #2 for the 2022 Water System Improvement Project. Faber abstained all other ayes, motion carried.

On a motion by Granstra and a second by DeKam to approve pay request #5 for the 2022 Water System Improvement Project in the amount of \$387,527.17. Faber abstained all other ayes, motion carried.

The Council discussed applying for a grant from the IDNR to replace a well that was closed due to possible polyfluoroalkyl contamination. The grant program provides a forgivable loan to replace wells that may have polyfluoroalkyl contamination with wells that do not have any trace amounts of polyfluoroalkyl substances. DGR Engineering is preparing the grant application for the City.

City Administrator Van Maanen and Development Director Miller presented a draft City Park master plan. The plan covers the phasing of the project and the estimated cost of the project. The Council will consider the master plan at the January 5th Council meeting.

City Administrator Van Maanen discussed the ongoing debate between Waters Edge Aquatic Design and Iowa Department of Public Health regarding the safety of the proposed family slide at the new swimming pool. Van Maanen reported that he had a conference call with IDPH this morning and he believes that they will approve the slide with a couple of conditions, when the director of IDPH reviews the proposed slide on January 12th.

The Council reviewed a property tax valuation report for fiscal year 2023-24 tax levies. No action was needed or taken.

The Council reviewed a net taxable valuation and estimated TIF revenues report for fiscal year 2023-24. No action was needed or taken.

The Council reviewed a request for a proposed balcony over the public right-of-way in the business district. The Council was agreeable to the request and they asked the City staff to work with City Attorney Winterfeld to develop regulations regarding these types of structures.
