- **2. Project Background** The June flooding caused significant damage to bridges, trails, and associated infrastructure within the City of Rock Valley. The damage includes structural compromise to bridges, erosion of trail surfaces, and loss of drainage systems. This project aims to repair and enhance these structures to ensure long-term resilience and public safety.
- **3. Scope of Work** The selected firm will be responsible for:

1. Assessment and Design

- Conducting site visits to assess flood damage.
- Preparing detailed design plans and specifications for bridge and trail repairs.
- Incorporating flood mitigation measures and sustainability into designs.

 Contact information for at least three clients for whom the firm has completed similar projects.

- Qualifications and relevant experience (30%)
- Project approach and methodology (30%)
- Cost competitiveness (20%)
- Timeline and ability to meet deadlines (10%)
- References and past performance (10%)
